New Business Proposal A: Approved

Change name of Youngs **People's** Conference Committee to **Young Adults** Conference Committee.

New Business Proposal B: Approved wth amendments

Change Unity with Diversity Polity **from** - In particular, this means we do not try to convince any member or visitor to adopt a belief in God **To** - Our welcome extends to all faiths and beliefs and we do not try to convince anyone to adopt any specific belief system.

New Business Proposal C: Approved with amendment

Change wording from: In keeping with Tradition Ten, Overeaters Anonymous has no opinion on bariatric (weight loss) surgery. In the spirit of Tradition Three, Overeaters Anonymous welcomes anyone with a desire to stop eating compulsively, including those who have had bariatric surgery or are contemplating it. **TO:** In keeping with Tradition Ten, Overeaters Anonymous has no opinion on the various medically recommended methods of weight management. In the spirit of Tradition Three, Overeaters Anonymous welcoms anyone with a desire to stop eating compulsively.

Bylaw Amendment Proposal 1: Approved

Change wording from: There shall be eleven regions: one virtual region and ten geographic regions **TO:** There shall be ten regions: one virtual and nine geographic regions, **Also Regeion No. 3** shall be the Southwesst Region composed of Arizona, Colorado, Central and West Iowa, Kansas, Nebraska, Nevada, New Mexico, Oklahoma, South Dakota, Texas, and Utah. **Region No. 4** was dissolved/disbanded in July 2024 and ratified at World Servcice Business Conferencr 2025.

Region No. 5 shall be the Central Region composed of East Iowa, Illinois, Indiana, Kentucky, Michigan, Minnesota, Missouri (except Greater Ozarks Intergroup), North Dakota, Ohio, and Wisconsin. **Region No. 10** shall be composed of countries and territories in Australia, East Asia, New Zeland, Southeast Asia and the Western Pacifin Basin.

Bylaw Amendment Peroposal 2: Failed

Proposed Wording Board of Trustees, Qualificaions: Stated two specific ideas, in writing, to

improve the health and long-term survival of the Fellowship.

Bylaw Amendment Proposal 3: Passed with amendment.

The Board of Trustees shall consist of between thirteen and seventeen trustees ~~canged to:~~ between thirteen and sixteen trustees. *Proviso:* The number of trustees will be reduced by attrition as vacancies occur with no elected trustee being removed as a result of this amendment.

Bylaw Amendment Proposal 4: Failed

Amendments to Article 1 (Twelve Steps) and Article II (Twelve Traditions) of Subpart B of these bylaws may only be adopted if, in addition to d) above, they are ratified by three-fourths of the registered Overeaters Anonymous groups responding within six months of notifications,. ~~Struck:~~ provided at least 55 percent of the registered groups have responded,

Bylaw Amendment Proposal 5: Failed

Change the wording of the gender of God ~~from~~ Him ~~to~~ God in the Twelve Steps and Twelve Traditionf of Overeaters Anonymous.

Bylaw Amendment Proposal 6: Failed

The Conference shall be held via videoconferencing platform. *It will continue to be held on a two year rotation of in person and videoconferencing.*

Bylaw Amendment Proposal 7: Approved

Nondelegates will include volunteers.

Bylaw Amendment Proposal 8: Approved

Wording for the Meetings of Delegates to read: Such notice shall be sent no less than sixty days before each meeting and shall specify the **day(s), hour(s)**, method, and manner of the meetng.

Bylaw Amendment Proposal 9: Approved

Added wording: Current trustees not serving as a region liaison may submit their applications for re-election to the Board of Trustees for affirmation. At least ninety days prior to the annual Conference of Overeaters Anonymous, the Board of Trustees may affirm nominations received from current trustees not serving as region liaisons. All affirmed nominee applications shall be submitted to the Conference for consideration. Copies of applications must be sent to all Conference delegates at least forty-five days prior to the annual Conference.

Bylaw Amendment Proposal 10: Approved

Groups that choose not to affiliate with an intergroup or a national service board may choose to affiliate with the geographic region where the group exists or the Virtual Region.
